

Jaguar Land Rover Trade Panel Mystery Break Competition Terms

1. The Promoter is Motorcorp Distributors Limited.
2. Entry into the competition is deemed acceptance of these and any other applicable terms and condition.
3. The competition commences on 1 January 2026 and ends at close of business 31 March 2026 (**Promotion Period**).
4. If you are a Qualifying Customer who make an Eligible Purchase (as those terms are defined below) you will receive, free of charge, one or more entries into the prize draw to be into win a prize, as detailed below.
5. An eligible purchase means one or more purchases that satisfies all the following (an **Eligible Purchase**):
 - a) Is of genuine Jaguar or Land Rover parts from an authorised Jaguar Land Rover retailer in New Zealand during the Promotion Period;
 - b) has been invoiced for in full during the Promotion Period; and
 - c) contributes to the customer reaching a cumulative spend of at least NZ\$2,000 (GST inclusive) (**Qualifying Spend**) during the Promotion Period
6. Entry spend is cumulative across the Promotion Period. Customers will receive one entry for every NZ\$2,000 (GST incl.) of cumulative Qualifying Spend on Eligible Purchases. Examples:
 - a) \$4,000 cumulative = 2 entries;
 - b) \$2,500 cumulative = 1 entry;
 - c) \$1,800 cumulative = 0 entries.
7. Any returns, credits, or reversed transactions will reduce the customer's cumulative Qualifying Spend of the Eligible Purchase.

 - a) be a trade panel customer of an authorised Jaguar Land Rover retailer (**retailer customers are not eligible customers**);
 - b) have an active trade account which is in good standing;
 - c) have made an Eligible Purchase; and
